PROCESS

- Potential scholarship recipients must complete a scholarship application and email or mail it to the scholarship administrator (Alvenia.G.Scarborough@chemours.com) along with all supporting documentation by the established deadline of **April 12, 2019**.

CRITERIA

- Applicants must be completing or have completed high school successfully with a minimum GPA of 3.0 on a 4.0 scale.
- Applicants must be accepted as a full-time student at a college or university for the upcoming academic semester. If scholarship money is awarded, this is the only program that will receive the funds on behalf of the applicant.
- Applicants must plan to pursue studies in a field associated with STEM, MIQUA, technical or operation manufacturing support.
- Applicants must be a citizen or legal permanent resident of the United States.
- Preference will be given to students who attended high school in the city of Wilmington and are residents of the city of Wilmington. Greater Wilmington metro area students will also be considered after the priority group.
- Applicants must complete and submit a scholarship application by **April 12, 2019**.

AWARD

- Chemours awards scholarships based on a comprehensive evaluation process conducted by a cross-function committee drawn from the Chemours Philanthropy Leadership Team, CBEN Steering Team, and one CET member.
- Areas that are reviewed by the committee include, but are not limited to, the following:
 - Academic Accomplishments
 - References
 - STEM and future career aspirations expressed through a short personal essay/answer:
 - How do science and math factor into your future career plans?
 - What is the importance of STEM to societal innovation and progress?
 - Financial Need
 - Wilmington Resident
- Chemours will pay the scholarship fund directly to the educational institution.
- Scholarships are awarded annually to a maximum of three qualified students.
- Scholarships awarded are based upon the availability of funds and additional qualifying criteria.
- Maximum scholarship amount is \$10,000.

SCHOLARSHIP ADMINISTRATION

- The Chemours scholarship committee will lead the process for receiving and reviewing applications, selecting recipients, and making scholarship awards. The committee working together will read applications, determine the best candidate(s), and then vote for approval. We will then notify the recipient(s) and award the scholarship funds via phone call and official letter.
