# Future of Chemistry Scholarship Application 2024—Continued

### **PROCESS**

Potential scholarship recipients must complete a scholarship application and email or mail it to the scholarship administrator (Sonya.A.Melvin@chemours.com) along with all supporting documentation by the established deadline of March 15, 2024. Scholarship decisions will be made by Spring 2024.

### **CRITERIA**

- Applicants must be completing or have completed high school successfully with a minimum GPA of 3.0 on a 4.0 scale.
- Applicants must be accepted as a full-time student at a college or university for the upcoming academic semester. If scholarship money is awarded, this is the only program that will receive the funds on behalf of the applicant.
- Applicants must plan to pursue studies at a North Carolina community college or university, and be majoring in a STEM program or technical skills program.
- Applicants must plan to pursue studies in a field associated with STEM (Science, Technology, Engineering & Mathematics), reliability engineering or operations management.
- Applicants must be a citizen or legal permanent resident of the United States.
- Preference will be given to students who attended high school in Bladen, Robeson, or Cumberland counties.
- Applicants must complete and submit a scholarship application by March 15, 2024.
- A complete scholarship application must include all items on page 3 section 18.

### **AWARD**

- Chemours awards scholarships based on a comprehensive evaluation process conducted by a cross-function committee drawn from the Chemours Vibrant Communities and Philanthropy Leadership Team, and the Chemours Fayetteville Works Community Support Team.
- Areas that are reviewed by the committee include, but are not limited to, the following:
  - Academic Accomplishments
  - Reference letters
  - STEM and future career aspirations expressed through above answers.
  - Financial Need
  - Bladen, Cumberland, or Robeson County resident
- Chemours will pay the scholarship fund directly to the educational institution.
- Scholarships are awarded annually and are based upon the availability of funds and additional qualifying criteria.
- Maximum annual scholarship amount is \$10,000.

# SCHOLARSHIP ADMINISTRATION

• The Chemours scholarship committee will lead the process for receiving and reviewing applications, selecting recipients, and making scholarship awards. The committee working together will read applications, determine the best candidate(s), and then vote for approval. We will then notify the recipient(s) and award the scholarship funds via phone call and official letter.
